# Membership Categories and Rates (2018)

**Full Family Stockholder** - \$425 – **Stockholder**<sup>2</sup>. **Household**<sup>1</sup> has use of pool when open to general membership.

**Full Dual Stockholder** - \$300 – **Stockholder**<sup>2</sup>. Membership consists of at most two members, one of whom are 18 years of age or older (Max 2 members). Cannot be the sponsor of an associate family. Members have use of pool when open to general membership.

**Full Maintenance Stockholder**- \$200 – **Stockholder**<sup>2</sup>. Maintains ownership of stock but does **not** have swimming privileges. Cannot be the sponsor of an associate family.

**Associate Family**- \$350 - **Non-stockholder**. Must be sponsored by a stockholder parent who is paying the regular "Stockholder" rate. **Household**<sup>1</sup> has use of pool when open to general membership.

**Summer** - \$525 - **Non-stockholder**. **Household**<sup>1</sup> has use of pool when open to general membership.

**Active Duty Military** - \$425 - **Non-stockholder**. Member of **household**<sup>1</sup> must be on active duty in the US military. Household has use of pool when open to general membership.

## **Notes:**

1. Membership "**Household**" is defined as: two named primary adults and their dependent children (up to age 26) who all reside together at the single address identified on the membership application during the summer swim season.
2. **Stockholder** - May serve on the Idle Hour Board of Trustees and vote in Idle Hour elections.
3. Stockholders must pay one of the stockholder renewal rates plus applicable fees EVERY year or forfeit their stock in accordance with the by-laws.
4. Add-on: Any adult, over the two named primary adults, past age 26 living in the household must be paid for as an additional add-on person, cost \$75. Only valid for Full Family Membership. If not listed on membership and paid for, individual will be required to use guest pass for entrance.
5. Unlimited Guest Pass \$100: May be added onto any membership level/type. For one named person for the entire summer. (Example: babysitter, aunt, parents not living with members, etc.)
6. Guest pass booklet (10 punch card): \$40 for members only.
7. A Capital Improvement Fee (per language in the by-laws) - This is an additional fee for Stockholder memberships with pool use privileges (Family and Dual). This is separate from membership dues and will go into a separate fund to only be used for capital improvements to Idle Hour property and pool. These funds will go towards items such as: a new vinyl pool liner, improvements to the back lot, repair of the concrete decking around the pool.
8. A Maintenance Fee (per language in the by-laws) - This is an additional fee for Stockholder memberships with pool use privileges (Family and Dual), typically paid in the fall. This fee will cover property taxes, insurance, and maintenance of facilities and grounds.
9. Refer a friend – Receive a guest pass booklet (10-punch card) anytime you refer someone and they join/pay in full to become members of our pool club.
